- Arizona "C" Corporations (A.R.S. § 43-1183) and "S" Corporations (A.R.S. § 43-1089.04) including LLCs taxed as "S" Corporations can redirect 100% of their state income tax to scholarships to support Muslim students with a minimum contribution of \$5,000.
- There is **no maximum contribution** amount just a minimum of \$5,000 per company and a statewide cap of \$158 million.

HOW DOES THE CORN ORATE HAR CREDIT WORK.	

The Corporate Tax Credit program is not actually a donation. Contributions are tax credits, which means **NO out-of-pocket cost to your company**, but rather a **dollar-for-dollar credit** on your state income tax! Instead of paying state income tax to the State of Arizona, you'll be redirecting that money to assist low-income students in need. Here's how it works:

- You will **provide an amount** of how much you would like to contribute beyond the minimum contribution (\$5,000) based on your estimated state tax liability for this year or your previous year's state tax liability. We will collect a few more details about your corporation (name, address, EIN) and **we will prepare an application** to submit to the Arizona Department of Revenue for approval.
- Applications are **approved by the Arizona Department of Revenue** on a first-come first-served basis until the \$158 million state-wide cap is reached. Once approved, **your company will have twenty days** to make a contribution.
- At tax time, the corporation, or the individual owner in the case of an "S" corporation, **claims the corporate tax credit** for the amount contributed.
- The State of Arizona will then provide you with a credit against the corporation's state taxes for **100% of the amount you contributed**. If a corporation donates more than its tax liability, it can be carried forward for up to 5 years. (A.R.S. § 43-1089.04).
- If you are already taking advantage of the individual tax credit, your company can still participate in the corporate tax credit program!
